## **Legislative Committee Minutes 6-12-2025**

The Committee meeting began at 9am on June 12, 2025, after meeting properly noticed with the WV Secretary of State and the committee started by reviewing proposed rule changes discussed by the WV BOP during the Executive Order 6-25 process during Spring 2025. The Committee proceeded to discuss draft revisions of WV CSR §15-1-1, §15-7-1, §15-10-1, §15-12-1, §15-15-1, and §15-16-1 *et seq* as proposed in the letter and appendix for Executive Order 6-25.

1. WV CSR §15-1-1 The Committee agreed to make changes from “Rules of Professional Conduct” to a list of “Unprofessional Conduct” using the NABP Model rules as the initial draft.
2. WV CSR §15-7-1: remove the 20 hour program as discussed and all other changes approved
3. WV CSR §15-10-1: update PRN to reflect time period for change in intern license.
4. WV CSR §15-12-1: as proposed. No additional changes
5. WV CSR §15-15-1 as proposed. No additional changes
6. WV CSR §15-16-1: as proposed. No additional changes
